1. Introduction

3. Acceptable Use

- 3.2 **Prohibited Activities:** You may not use the Service for any of the following purposes:

- 4.3 The downloaded file contains instructions on how to create a TXT record in your domain's DNS settings. Please follow these instructions carefully, replacing _yourverificationhostname.example.com with the unique hostname provided during signup.

Here's how to complete the verification process:

Download the verification record template from the link above. Open the downloaded file. It will contain pre-filled information similar to this:

Hostname: _yourverificationhostname.example.com

Record Type: TXT

Value: "This is a verification record for domain ownership verification

purposes."

Important: Replace _yourverificationhostname.example.com with the unique domain name used during signup.

- Log in to your domain name registrar's control panel and access your domain's DNS settings.
- Follow the instructions provided by your domain name registrar to create a new TXT record.
- Copy and paste the information from the downloaded file (including the modified hostname) into
 the corresponding fields when creating the TXT record in your DNS settings. Make sure to copy the
 exact string, including the quotation marks.
- Save your changes in your domain name registrar's control panel.
- 4.4 Once you have added the TXT record to your domain's DNS settings, it may take some time for the change to propagate across the internet. **Please allow up to 24 hours** for our system to verify ownership.
- 4.5 After successful verification, your domain ownership will be confirmed, and your free hosting account will be activated or continued without interruption.
- 4.6 We reserve the right to suspend or terminate your account if your resource usage exceeds the limits of the free plan or negatively impacts the performance of the Service for other users.
- 5. Account Suspension and Termination
- 5.1 We reserve the right to suspend or terminate your access to the Service for any reason, with or without notice, if you violate any provision of these TOS or our AUP.
- 5.2 **Suspension and Termination Process:** In the event of a potential violation, we will attempt to notify you via email and provide an opportunity to rectify the situation. However, we reserve the right to suspend or terminate your account immediately and without notice in cases of severe violations or ongoing threats.

- 5.3 **Appealing Suspensions or Terminations:** If your account is suspended, you may appeal the suspension by contacting our support team at [your support email address] and explaining the situation.
