

WebHostingM: Promo Credit Terms & Conditions

WebHostingM can verify customer eligibility and correct credit usage. Suspected abuse, fraud, or violation of these Terms may lead to immediate credit cancellation and account termination. These Terms are

governed by the laws of the U.S state where our business entity is registered and any disputes fall under the exclusive jurisdiction of such courts. These Terms represent the full agreement between WebHostingM and customers about credit usage, overriding any previous agreements or understandings, whether written or verbal.
